

Law Reports

This guide includes three listings of the Library's Law Report holdings.

The main listing is an alphabetical listing with the most common abbreviation and the dates of the Library's holdings noted. For the nominate reports, the volume in the English Reports (ER) (LR/1) or Revised Reports (RR) in which the set of law reports is reprinted is included. The next column indicates the shelf mark of the set of law reports to help locate the set in the Library, whilst the final column indicates if the law report is a series available on Westlaw UK or Lexis Library (applies to the UK series only).

There is also a listing of post-1865 law reports by jurisdiction or geographical area and a listing of the post-1865 English law reports by subject.
